We are pleased to inform you that the Commodore Perry School District will be implementing a new provision known as the Community Eligibility Provision (CEP) in the 2022-23 school year. No further action is required of you. Your child(ren) will be able to participate in these meal programs without paying a fee or submitting an application.
